1. Acceptance of conditions

By registering, the participants will accept the conditions explained below.

2. Entry conditions

The game is open to all customers who spend a minimum of € 45 all taxes included on American Crew products in a single transaction in the Duty Free shops at Paris Roissy Charles de Gaulle Airport or Paris Orly Airport.

Participants must be over 18 years old.

The directors, officers, employees and immediate families of the promoter or the agencies or companies associated with this contest are excluded from this contest. Immediate family means one of the following : spouse, former spouse, common-law partner, child or step-son (natural or adopted), parent, step-parent, grandparent, grandparent, uncle Aunt, niece, nephew, brother, sister, half-brother, sister-in-law or first cousin.

3. Duration of the competition

Participants can only register once using a single email address. All entries must be received by the promoter during the period of the game. The Promoter declines all responsibility for late, lost, incomplete, incorrectly presented, delayed, illegible, corrupt or misdirected registrations, or for complaints or correspondence due to an error, omission, modification, alteration, deletion, theft, destruction, interruption of transmission, failure of communication or otherwise. Participants who use multiple e-mail addresses or aliases will be disqualified.

5. Declaration of confidentiality and personal datas
